# DECISION ADOPTED BY THE CONFERENCE OF THE PARTIES TO THE CONVENTION ON BIOLOGICAL DIVERSITY

15/8. Capacity-building and development and technical and scientific cooperation

The Conference of the Parties,

Recalling Articles 15.6, 16, 17, 18 and 19 of the Convention,

Recalling also decisions XIII/23 and 14/24,

Noting with appreciation the support provided by Parties, other Governments, the Global Environment Facility, relevant organizations and other stakeholders for capacity-building and development, and technical and scientific cooperation activities to assist developing country Parties, Parties with economies in transition, indigenous peoples and local communities, women and youth,

Reaffirming the need to promote strategic and coherent approaches to capacity-building and development and technical and scientific cooperation in supporting the implementation of the Convention and its Protocols.

Decision <u>15/8</u> on *Capacity-building and* development and technical and scientific cooperation invites universities and other academic institutions to support the Kunming-Montréal Global Biodiversity Framework.

The Conservation And Sustainability Consortium of AcaDEmic institutions (CASCADE) has been established to respond to this invitation.

# **CASCADE Strategy**

Key Strategies to Improve Capacity-Building and Development

**Promote partnerships and networks for implementation**. Establish and strengthen partnerships for effective mobilization of capacities and resources; the sharing of existing knowledge, expertise and ....

**Promote North-South cooperation**. Support capacity-building and development in developing countries ....

**Promote South-South and triangular cooperation**. Support capacity-building and development in developing countries that have common challenges and share similar characteristics (e.g. economic and social conditions and language) ...

Strengthen the monitoring and evaluation of capacity-building and development interventions. Develop and implement adaptive management systems for monitoring and evaluation of biodiversity capacity-building .....


#### I. Introduction

- 1. Over the past two decades, multiple workshops and consultations have been organized to advance the development of indicators for tracking the sustainable use, harvest, and trade of wild species. These efforts have involved collaboration among conservation organizations, governments, and academic experts. Among these initiatives, the Collaborative Partnership on Sustainable Wildlife Management (CPW) has played a central role, leading two significant events: the 2019 Consultative Workshop on Sustainable Wildlife Management Beyond 2020 and the 2020 CPW Virtual Workshop on Wildlife Harvest, Use, and Trade Targets and Indicators. These events contributed to the refinement of indicators, particularly addressing gaps related to the Aichi Targets, and resulted in the formulation of Target 5 of the Kunming-Montreal Global Biodiversity Framework (GBF), which focuses on ensuring sustainable, safe, and legal harvesting and trade of wild species.
- 2. A critical challenge consistently highlighted is the lack of sufficient data collection and monitoring systems at the national level, which hinders the ability to compute these indicators reliably. Many countries lack the legal frameworks and infrastructure necessary to gather
